The undersigned assumes full responsibility for any such injuries or damages which may occur, and further agrees that The Pintoon, LLC. shall not be liable for any loss or theft of personal property. The undersigned specifically agrees that **The Pintoon, LLC. shall not be responsible for any such injuries, damages, loss or theft, EVEN IN THE EVENT OF NEGLIGENCE BY THE PINTOON, LLC.** whether such negligence is present at the signing of this Release or takes place in the future.
